Adelaide Tilt Service Pty Ltd (ATS) – Terms & Conditions

Standard Trading Conditions – Effective from October 2013

1. Quotation

- 1.1. Where a Quotation is supplied by ATS, the agreed quote is valid for 14 days.
- 1.2. Quotes may be obtained orally or in writing.
- 1.3. Customer acknowledges quotes may not include GST and do not accommodate for fees incurred by hold ups & complications. ATS may invoice for late notice cancellations of booked in work, where it is too late to book in another job or if the task was not as described.
- 1.4. ATS may offer a 14 day account or require Cash on Delivery (COD) depending on the job specifics.
- 1.5. ATS will provide the customer with a Credit Application form with attached terms & conditions to be completed prior to commencing a regular business relationship.
- 1.6. In the event of business with a new customer and the job is proposed to be a once-off or an urgent job, a credit application form may not be supplied until the delivery of the invoice. Terms & Conditions are still valid and apply to works undertaken.
- 1.7. By accepting a quote for transport, the customer accepts the trading conditions and is bound to these terms & conditions.
- 1.8. ATS requires all Purchase Order numbers, Consignment Notes & other Job information such as Addresses & Contact information prior to commencing work.
- 1.9. ATS reserves the right to know the details and contents of goods to be transported. ATS may refuse to accept to transport Goods for carriage without any reason.

2. Payment & Terms

- 2.1. Invoices must be paid in full.
- 2.2. ATS accepts Cash, Cheque & EFT transfers.
- 2.3. Terms are 14 days from date on invoice.
- 2.4. The Customer may discuss with ATS accounts department if you wish to extend your trading terms. Approval must be in writing.
- 2.5. ATS will advise a recommended Credit Limit for businesses offered a 14 Day account.
- 2.6. Overdue accounts may be charged interest at the rate of 2 per cent per month on any overdue amount calculated from the due date until payment is made in full. Such interest will be payable on demand by ATS.
- 2.7. Customers are accountable for all recovery costs of overdue amounts. This may include ATS pursuing legal avenues.
- 2.8. ATS reserves the right to suspend or reduce the limit of a customer's credit account if outstanding overdue balance is not paid.
- 2.9. The Customer must notify ATS in writing if there is any change in the shareholding or ownership of the Customer (if applicable) or any material change in the Customer's financial position.
- 2.10. The Customer must notify ATS if their company information has changed.
- 2.11. The Customer must notify ATS in writing if they have any complaints in regards to ATS Services within 7 days of job.

3. Representations & Liability

The Customer (on behalf of itself, the consignor and the consignee) represents and warrants to ATS that:

- 3.1. the Goods are fit for carriage and storage;
- 3.2. the Goods are packed to withstand ordinary risks of handling storage or carriage road transport, having regard to their nature;
- 3.3. the Goods are the correct weight as described;
- 3.4. the Goods do not contain any explosive or volatile spirits or other items of a dangerous, inflammable or offensive nature;
- 3.5. the Goods and the performance of the Services in respect of the Goods are not prohibited by law;
- 3.6. it is the legal owner of the Goods or legally entitled to authorise their carriage;
- 3.7. all information provided to ATS in connection with these Trading Conditions (including all load information related to any Container or Goods) is true, accurate and complete, and is not, by omission or otherwise misleading;
- 3.8. it has complied with all laws relating to the nature, condition, packaging, handling, storage and carriage of the Goods;
- 3.9. Storage & Transport of any Container, Goods or Machinery is at the sole risk of the Customer. ATS is not responsible for any loss or damage in respect of Containers or Goods within while the Containers or Goods are under the care, custody or control of ATS.
- 3.10. The final destination is equipped and prepared for the Good's arrival and there is no probable delays in transit.
- 3.11. ATS will not effect insurance on the Goods. All such insurances effected by ATS are at the Customer's cost, and are subject to the usual exceptions and conditions of the policies of the insurer or underwriter taking the risk. At the discretion of ATS such insurance may name the Customer or owner as insured. In the event of any dispute in regard to liability under any such insurance policy for any reason whatsoever the Customer or other insured will have recourse against the insurer or underwriter only and ATS will have no liability or responsibility in relation to any such insurance policy. In the event that damage occurs to ATS property at the fault of the Customers negligence, ATS will seek compensation where reasonable after an investigation into the matter.
